This semantic change has led to a change in its actors' role and place.

This word confusion is in fact a smart move to shift power.

Speaking of health policy, the politician and the bureaucratic take over the health care system.

Not only do they have an upper-hand position with respect to the Medical Doctors; but they also convince us that they help us.

Global Anatomy Dissection Network

Surgery and surgeons require a profound knowledge of anatomy. It is common sense to have mandatory training in an anatomy laboratory. Generations of surgeons have confirmed that learning process in an anatomy laboratory improves performances in the operating room for both juniors and seniors. Contrarily, from a practical and ethical viewpoint, the operating room cannot be considered the sole place for learning surgical techniques.

However, it is a common fact that teaching and training on cadaver specimens are not easily done, and even impossible in many centres and many countries.

Why such a gap between wishes and reality? And how to solve this contradiction?

Surgeons are no longer the charismatic leaders in the medical field. Non surgical procedures are more and more promoted as conservative *versus* radical and invasive surgery.

Conservative procedures present the additional advantage of not requiring long training and being supported by powerful companies. Consequently there is a trend in official institution to not highlight surgical training. There are so many good reasons (legal, religious, economic, structure, time...) to make access to anatomy inaccessible.

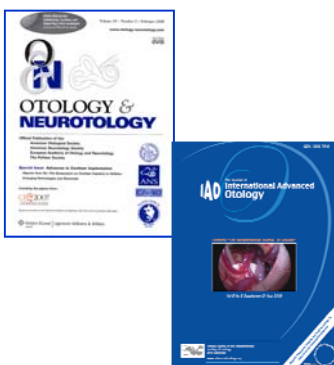

Nevertheless, here or there, some public or private centres of excellence try to develop as well as they can anatomy dissection courses on temporal bone. Only a few of them are privileged to be allowed to collect great amount of cadaver specimens.

With globalisation, it seems self-evident to link up different centres and to set up a global anatomy network for surgical training via advertisements, promotion, exchanges and videoconferencing. Our professional societies (regional, national, international) have learnt how to promote scientific meeting, but still have to do the same for anatomy dissection courses which are still confidential.

Politzer society could be the international platform for listing the calendar and organization of the different temporal bone and skull base dissection courses, especially those using heads from fresh cadavers allowing to study skull base and neurotologic surgery. This is of course a completely non profit group.

The goal is to be grateful to the centres offering anatomy dissection and regular courses, and to support them. It is also a way to lobby institutions to develop such anatomy structures and programmes to allow better anatomosurgical know-how and to gain time for the learning curve.

The final purpose is that all Head & Neck surgeons and each component of ORL, otology, rhinology, laryngology, get at least minimal anatomical and surgical training. For those who would like to extend their expertise to neurotologic and skull base surgery could benefit from anatomy laboratories to perform all surgical approaches reaching deep and delicate vasculoneural structures. Thus they will become more familiar with advanced microsurgical and endoscopy procedures.

On one hand Medicine loses its autonomy, on the other hand the physician loses his independence and freedom. Public health policy in general and "securite sanitaire" in particular, although necessary and useful, have as side effect "to domesticate" Medicine.

This trend to control and domesticate is achieved through complex and finicky management and accounting rules which distracted the physician and his team from their real medical expertise and mission.

Technocrats have very skillfully brought the physician onto their technocratic playing field, "health policy", and so they have weakened the medical power. It is a bite like a football team which never plays at home, but always in the other team's stadium.
